I. I understand that all students going on this trip will conduct themselves in accordance with Holy Cross High Schools Student Handbook. It is further understood that students will go and return from the event in the transportation provided. I, the undersigned parent/guardian, assume financial responsibility should the above-mentioned student have to return to Holy Cross prior to the end of the trip. Only eligible seniors are allowed to go on the senior trip; no guests are allowed. **Students must turn in all required paperwork and pay for all fees by the established deadlines in order to reserve a seat on the bus.**

II. I understand that if my son is involved in an illegal activity, including but not limited to, the use/possession of alcohol and/or drugs, theft, shoplifting, as identified by the appropriate theme park, resort and/or local and/or state authorities and/or our school district chaperones will result in the following: A parent/guardian must escort their child home. This will be done at their own expense. In addition to being sent home, the following shall occur:

1. The student will not be eligible to attend the prom.
2. The student will not be eligible to participate in commencement exercises.
3. Disciplinary action will be taken upon the student's return to school.

III. I hereby give permission to have my son's backpack searched by the chaperones on the class trip for illegal substances prior to boarding the bus. I understand this is being done for the safety of the student and others on this trip

ELIGIBILITY: Students must be in good Academic and Financial standing. Students who are on Academic Probation, and/or have not yet completed their Service Hours are not eligible to go on the Senior Trip. Eligibility will be determined based on third quarter grades, and all requirements are listed in the **Holy Cross Student Handbook.**

The **TOTAL COST** of the trip is **\$120.00**. This includes the ticket for the theme park, *lunch/beverage*, and transportation. The **NON-REFUNDABLE** payment is due in 4 installments.
