#### Francis W. Korzekwinski '80

This year we are pleased to pay tribute to our honoree, Francis W. Korzekwinski, Class of 1980, Senior Executive Vice President of Flushing Bank.

As leadership sponsors of the annual Holy Cross High School Golf and Dinner Classic for the past 25 years, Frank and Flushing Bank have made a significant impact in attracting academically gifted students to the school through the Alumni Scholarship Fund, which provides full, four-year scholarships to Holy Cross students.
